D. EARLY LEARNING PROGRAM GOVERNANCE

Recommendation from Head Start Advisory Committee:

This item was reviewed and approved as a whole by the Head Start Advisory Committee on June 2, 2015 and recommend full Board approval.

Explanation:

The governing body has legal and fiscal responsibilities and for administering and overseeing all programs under its authority. As part of program oversight the PSESD Board reviews and approves periodic programmatic reports, process and outcomes, such as, but not limited to program Self-Assessment, sub-contractors, program models, ERSEA, monitoring reports and funding applications.

Policy Council approved the conversion of 18 Full Day enrollment slots at Educare to Part Day enrollment slots, and to move those 18 Part Day enrollment slots to Highline SD Hilltop Elementary. The now available classroom at Educare then would be divided into 2 infant and toddler classroom serving an additional 16 infant and toddlers at Educare. It should be noted there has been on-going under enrollment for preschoolers at Educare while there has been an on-going wait list for infant and toddlers. The new infant and toddlers at Educare would be funded through the new Early Head Start — Child Care partnership grant.

Approve the conversion of 18 Full Day slots at Educare to Part Day slots, and to move those 18 Part Day slots to Hilltop, convert the available classroom at Educare into two rooms to serve 16 new infants and toddlers.
